

The Election Commission of India has announced biennial –bye elections to the Karnataka Legislative Council from Karnataka South - East Teacher constituency. The model code of conduct issued by the Election Commission vide letter cited at ref(3), is in force. The press note dated -04-01-2017 of the Election Commission and the model code of conduct issued by the Election Commission has already been communicated to the Principal Secretary, Higher Education Department vide this office letter cited at ref(2).

With reference to the above subject and reference, I have been directed to bring it to your kind notice that there is no objection from the point of view of the Model Code of Conduct for the event subject to the following conditions ---

1. The Ministers shall not combine their official visit to the event with any election campaign for the ongoing elections to the Karnataka South East Teacher constituency.
2. No such function involving the teachers of the five districts of Davanagere, Kolar, Chitradurga, Chikkaballapur and Tumkur , who are electors for the said bye-election shall be held in these five districts.
3. No election related officer – the Returning Officer, Asst Returning Officer, MCC enforcement officer etc shall take part in the said function.
4. The teachers who are voters for the said biennial –bye election and who are from the five districts of Kolar, Chikkaballapur, Chitradurga, Davanagere and Tumkur shall not take part in the said event.

5. Distribution of T shirts, food etc shall not be undertaken under the said programme in the five districts of Tumkur, Kolar, Chikkaballapur, Davanagere and Chitradurga, from where elections are being held, nor to any electors from these districts.
6. No reference shall be made in speeches or media communication about the ongoing Biennial election process.
7. No political speech shall be made at the event.
8. No policy- announcement or achievements should be communicated through print or electronic media which could influence the electors of the said constituency, directly or indirectly.
9. The instructions contained in the Commission letter No 322/ECI/INST/FUNC/BIEN-LC/2016 dated 26<sup>th</sup> Dec 2016 on application of Model Code of Conduct shall be followed.

A copy of the Model Code of Conduct issued by the Election Commission letter dated 26<sup>th</sup> December 2016 is enclosed for kind reference and compliance.


